The Tsunami Society will hold its Fourth International Tsunami Symposium on July 25 - 29, 2010, in Toronto, Canada, in conjunction and mutual co-sponsorship with the 9th US National & 10th Canadian Conference on Earthquake Engineering.

The joint conference will provide the opportunity to expand the scope and themes to include the equally important engineering aspects related to both earthquake and tsunami dynamic motions. and impact on coastal structures and critical infrastructure facilities. 

- Freedom from commercialism


Notification of Provisional Acceptance

Authors will receive email notification of provisional acceptance of their abstracts by **Septmeber 15**, **2009**. Format requirements for submission of full papers will accompany the notification.

Submission of Papers for Review

Final papers must be received by **November 30**, **2009**. A non-refundable deposit of \$200 must accompany the submission of each paper. Only one \$200 deposit will be credited to the conference registration fee of each presenting author. Final papers will be reviewed using the same criteria as for abstracts; however, the papers will also be reviewed for relevance to the topic for which they are proposed.
